Fireplace Maintenance:

The board would like to continue to remind everyone about the proper usage and disposal of material from the fireplace. Ash MUST BE deposited behind the designated boat storage area, east of the eastern breakwater. Do not mix sand with ashes!! It creates a mess on the beach and in the fireplace. Do not extinguish fire with sand! Ellen did put up a sign on the back log behind the fireplace indicating where to dump the ash.

Family Picnic:

The annual Benton Family Picnic will be held on Saturday, July 31st starting at 1:00pm. The downpour date will be Sunday, August 1st. The theme is "old fashioned favorites". This can include recipes and clothing if you would like. Ellen sent out a notice about the family picnic. Tide is high at 3:16pm. Bring one main dish and an appetizer or a dessert. Bring your own drinks. The board will provide the paper goods.

Tornado Damage:

On Roger's Island there were about nine sumac trees that came down during the high winds from the recent tornado. Todd Chemacki brought down his chain saw to cut down the trees and then moved the brush with Joel. He also pulled the stumps of the trees out with his truck. Joel then filled in the holes with the sand to level out the ground. Todd brought the stumps to the stump dump. As a result of the damage there is almost a natural window view to the ocean from Roger's Island. Todd made a motion to cut the remaining brush (no existing trees to be cut) no bigger than 10ft wide to create a natural window view to the ocean. A board member must approve this and be present during the cutting. Ellen seconded the motion and it carried.

Picnic

Tables:

Ellen is taking one of the benches home from the old round table to fix. While the benches are still in decent condition the current round table is unable to be fixed and not usable. Joel made a motion to authorize Ellen to spend up to \$200 to buy a new round picnic table (without benches) that she has researched that is similar to the existing table under the canopy. Todd seconded it and it carried.

Cabana

Repair:

Donna spoke to Edwin about the cabana umbrella that is in need of repair. Edwin agreed to get the chicken wire to use as a base for the umbrella. Edwin is also willing to teach a few people how to redo the umbrella. Donna will touch base with Edwin when she returns from vacation about the next step. It may be a possibility to gather the phragmites needed at the fall "work day".

Outhouse

Maintenance:

The beach is a busy place in the summer. Therefore, hosts of events are responsible for the cleanliness of the outhouse both before and after an event. This includes cleaning the inside of the stall (cleaning supplies located on the shelf above the toilet seat). Also, if the sawdust pile under the seat is high, hosts should unlatch the back panel of the bin and use the wire rake located there to rake the pile towards the back of the bin.

Outhouse

Repairs:

The board has recently noticed that the ventilation screening in the outhouse was covered up by fiberglass panels when it was built. This makes the outhouse very hot. Ellen will ask Eliot if he is willing to cut the fiberglass over the vents. Agreement With Zabels:

The recent tornado damaged the west fence line on the Zabel's property. Billy Zabel seemed to imply that the fence line stated in the agreement referred to the fence line on all sides of his property. The intention of the board was to only refer to the fence line that runs through the Zabel's property. The document does not address all four sides. The Zabel's attorney will contact Joel to update the agreement.

Beach Road:

Todd and Ellen pulled down some hanging branches on the beach road after the tornado. Joel and Ellen will take some more of the brush and branches into the brush pile in the long lot. There is also a cherry tree on the Leary's property that is close to falling down. It would block the road if it does. Ellen was concerned about the stakes on the side of the road from the survey last year. Joel stated that some of the stakes, not all, are property markers that cannot be removed by law. The stakes that are tie lines can be taken out. Joel suggested that the stakes that are boundary markers be pounded in a few more inches to make them slightly less visible. Joel will do that when he mows this week.
