Quorum:

The meeting was called to order at 7:25 p.m., with a quorum present, at the home of Carolyn Helander, 404 Clapboard Hill Road, Guilford, CT.

Secretary's

Report:

The minutes for the meeting held on February 7<sup>th</sup>, 2011 were read aloud. Changes to the minutes included changing the title date from '2010' to '2011' as well as the day of the next meeting from 'Monday' to 'Tuesday'. Lynne made a motion to accept the minutes as amended. Todd seconded

the motion and it carried.

Treasurer's

Report:

Ellen reported that there had been \$1587.74 in income received for the period and \$1037.11 in expenses. The opening balance on 2/07/2011 was \$2766.82 with a closing balance of \$3317.45 as of 4/05/2011. Kate made a motion to accept the treasurer's report as presented. Lynne seconded the motion and it carried. A copy of the report is enclosed as well as a copy of the 2010 Year-End Financial Report. There was also discussion about what to do with the Capital Fund account since the CD it was in matured in March. The last CD interest rate was .9%. There was discussion about possibly putting it into a conservative money market fund but in the end the board concluded it was best to keep the fund in the most conservative place possible which would be a CD. Lynne made a motion to put the Capital Fund into a 10-month CD for 1.0% with Guilford Savings Bank.

Zabel

Fence Line: At the last Board of Directors meeting it was discussed that a survey

needed to be done on the fence line and Joel has already contacted Russ Waldo Associates. They had already agreed to survey our common boundary for \$1000 (cost split evenly between BBC and Zabels), which would include staking and putting in three concrete monuments. The fence line will need red cedar poles to go about every 10' of the 253' fence line. We are now waiting for the surveyor (Waldo Associates) to come in to stake the fence line. It is on their docket and should be done in the next few weeks. Forrest Helander was the only family member to respond to the inquiry for setting poles. Joel will follow up with Forrest as to the

timeline, based on Waldo Associates.

Regular

Fence Line: A few members of the board did partake in the fence walk on March 5th.

The conclusion of the walk was that there is a section of the fence line parallel with the beach road that needs to be repaired. This spot is currently only reinforced with rope. The family fence work day will be on

April 30th starting at 8am with a rain date on May 1st.

Pasture

Maintenance: At the last Board of Directors meeting the need to cut and spray the rose

bushes in the Long Lot again this year was discussed. However, new information and concerns were brought to the table by shareholders about the negative impact of the herbicide Roundup (which was sprayed on the rose bushes last year) to both humans and the environment. There has been a lot of new literature in the last two years that talks about the dangers of the surfactant POEA which is what the active ingredient from

Roundup, Gylphosate, is suspended in. Joel did a lot of research on this topic and put together literature for the board to read before any decisions were made about spraying the rose bushes with Roundup again. Ellen made a motion to suspend the spraying of Roundup for this year while still cutting the rose bushes. Lynne seconded it and it carried. Joel will contact Bill Leete to see if he can cut the rose bushes on a date at his convenience.

a.m. Reminder notices will be sent out a few weeks before the event.

Cattle: Ellen drafted a letter to the Hammurlands again this year to encourage them to bring the cattle into pasture in early May.

# Property line

Trees: At the last Board of Directors meeting discussion was had about the fact that Bill Gunther, who owns the property west of 410 Vineyard Pt. Rd., approached Joel about the possibility of cutting a few cedar trees on Benton Beach property. The board looked at these trees during the fence walk. There was concern that these trees are the only fully grown trees in the area now that Zabel's have cleared their property and that the cattle use them for both shade and scratching. The board agreed to deny Bill Gunther's request to cut down these trees. However, Joel talked with the Hammarlunds who indicated that groves of trees should be created, not hedgerows, which is what many of the cedar trees in that area are creating now. Board members will arrange to go to the meadow on Saturday, April

16<sup>th</sup> to make a plan as to where groves should be created.
